**Carteret County COVID-19
Age and Gender Breakdown
Current as of 04/20/20, 8:00 am**

Carteret County, NC – As of April 20, 2020, Carteret County has not received any new COVID-19 confirmed cases and remains at 24 confirmed cases in the County. Of the 24 confirmed cases, 5 patients are active cases, 17 of those patients have recovered and have satisfied the NC Department of Health and Human Services (NCDHHS) isolation requirements, and 2 are deceased. Carteret County medical providers, including the Health Department, have collected specimens for COVID-19 testing for 436 patients resulting in 24 positive confirmations, 1 inconclusive, 395 negative results and 16 pending test results.

Total Confirmed Cases: 24 (Of the 24 cases, 17 persons have recovered and fulfilled their isolation requirements per NC DHHS guidance).

*NOTE: As you review the age and gender data, please be aware this data is preliminary and may change as cases are investigated. Percentages may not sum to 100% due to rounding. Also, the age and gender data are representative of the confirmed cases, not of all COVID-19 cases in Carteret County.
