**Carteret County COVID-19
Two Additional Confirmed COVID-19 Cases
Press Release #62**

Carteret County, NC – On June 10, 2020, Carteret County received two additional confirmed positive cases for a total of 48 confirmed cases of COVID-19 in the County. Of the 48 confirmed cases, 9 patients are active cases, 36 of those patients have recovered and have satisfied the NC Department of Health and Human Services (NCDHHS) isolation requirements, and 3 are deceased. Carteret County medical providers, including the Health Department, have collected specimens for COVID-19 testing for 1058 patients resulting in 48 positive confirmations, 1 inconclusive, 956 negative results and 53 pending test results. Residents should contact their healthcare provider or the Health Department to see if they meet testing criteria for COVID-19 even if they are not symptomatic.

Total Confirmed Cases: 48 (Of the 48 cases, 36 persons have recovered and fulfilled their isolation requirements per NC DHHS guidance).

*NOTE: As you review the age and gender data, please be aware this data is preliminary and may change as cases are investigated. Percentages may not sum to 100% due to rounding. Also, the age and gender data are representative of the confirmed cases, not of all COVID-19 cases in Carteret County.
