Carteret County COVID-19 2nd Dose Vaccinations Press Release #105

Carteret County, NC – The Carteret County Health Department reminds those individuals who are scheduled to receive their 2nd dose vaccinations on February 8, 2020 to report to the Civic Center, 3505 Arendell St, Morehead City, NC 28557, at the time specified on their COVID-19 Vaccination Record Card. If your card only specifies the date of February 8, 2021, please be at the Civic Center between 8:30am and 2pm to receive your 2nd vaccination.

This clinic is for 2nd dose vaccinations only. Individuals need to bring their identification card and their COVID-19 Vaccination Record Card with them to receive their 2nd dosage. No walk-ins or 1st dose vaccinations will be administered at this clinic.

During the vaccination clinic, social distancing and a mask are required at all times. To eliminate unnecessary wait, please arrive no more than 15 minutes prior to your scheduled appointment. Please wear short sleeves or loose, non-restrictive clothing that will allow our vaccinators to access your upper arm/shoulder. Also, be sure to indicate to our staff if you had an adverse reaction to any vaccine in the past. Lastly, be prepared to wait 15 - 30 minutes after your vaccine to ensure there are no adverse reactions and you feel comfortable to return to home/work.
